Commission 7

SDG 1: No Poverty

1.4 By 2030, ensure that all men and women, in particular the poor and the vulnerable have equal rights to economic resources, as well as access to basic services, ownership and control over land and other forms of property, inheritance, natural resources, appropriate new technology and financial services, including microfinance.

- 1.4.1 Proportion of population living in households with access to basic services.
- 1.4.2. Proportion of total adult population with secure tenure rights to land, with legally recognized documentation and who perceive their rights to land
 as secure, by sex and by type of tenure.

SDG 2: Zero Hunger

2.3 By 2030, double the agricultural productivity and incomes of small-scale food producers, in particular women, indigenous peoples, family farmers, pastonalists and fishers, including through secure and equal access to land, other productive resources and inputs, knowledge, financial services, markets and opportunities for value addition and non-farm employment.

- · 2.3.1 Volume of production per labour unit by classes of farming/pastoral/forestry enterprise size.
- 2.3.2 Average income of small-scale food producers, by sex and indigenous status.

2.4 By 2030, ensure sustainable food production systems and implement realient agricultural practices that increase productivity and production, that help maintain ecosystems, that strengthen capacity for adaptation to climate change, extreme weather, drought, flooding and other disasters and that progressively improve land and soil guality.

2.4.1 Proportion of agricultural area under productive and sustainable agriculture.

SDG 5: Gender Equality

5.A Undertake reforms to give women equal rights to economic resources, as well as access to ownership and control over land and other forms of property, financial services, inheritance and natural resources, in accordance with national laws.

- S.A.1(a) Proportion of total agricultural population with ownership or secure rights over agricultural land, by sex; and (b) share of women among owners or rights-beares of agricultural land, by type of tenure.
- 5.A.2 Proportion of countries where the legal framework (including customary law) guarantees women's equal rights to land ownership and/or control.

SDG 10: Reduced Inequalities

10.2 By 2030, empower and promote the social, economic and political inclusion of all, irrespective of age, sex, disability, race, ethnicity, origin, religion or economic or other status.

10.2.1 Proportion of people living below 50 per cent of median income, by age, sex and persons with disabilities.

10.3 Ensure equal opportunity and reduce inequalities of outcome, including by eliminating discriminatory laws, policies and practices and promoting appropriate legislation, policies and action in this regard.

10.3.1 Proportion of the population reporting having personally felt discriminated against or harassed within the previous 12 months on the basis of a
ground of discrimination prohibited under international human rights law.

SDG 11: Sustainable Cities and Communities

11.1 By 2030, ensure access for all to adequate, safe and affordable housing and basic services and upgrade slums.

· 11.1.1 Proportion of urban population living in slums, informal settlements or inadequate housing.

11.7 By 2030, provide universal access to safe, inclusive and accessible, green and public spaces, in particular for women and children, older persons and persons with disabilities.

- 11.7.1 Average share of the built-up area of obes that is open space for public use for all, by sex, age and persons with disabilities.
- 11.7.2 Proportion of persons victim of physical or sexual harassment, by sex, age, disability status and place of occurrence, in the previous 12 month.


SDG 15: Life on Land

15.1 By 2020, ensure the conservation, restoration and sustainable use of terrestrial and inland freshwater ecosystems and their services, in particular forests, wetlands, mountains and drylands, in line with obligations under international agreements.

- 15.1.1 Forest area as a proportion of total land area
- 15.1.2 Proportion of important sites for terrestrial and freshwater biodiversity that are covered by protected areas, by ecosystem type

15.3 By 2030, combat desertification, restore degraded land and soil, including land affected by desertification, drought and floods, and strive to achieve a land degradation-neutral world

· 15.3.1 Proportion of land that is degraded over total land area
